- 1) Cases which cannot be fixed before D.B-I will be fixed as per direction of the Honourable Chief Justice. Cases which cannot be fixed before DB-II will be fixed before D.B-V and vice versa and cases which cannot be fixed before DB-II & DB-V will be fixed before D.B-IV. Cases which cannot be fixed before D.B-III will be fixed before DB-IV and vice versa and cases which cannot be fixed before D.B-III and DB-IV will be fixed before D.B-V. Cases which cannot be fixed before D.B-VI will be fixed before D.B-VII and vice versa and cases which cannot be fixed before DB-VI & DB-VII will be fixed before D.B-I (for further direction).
- 2) Cases under various act; Contempt of Court cases received from the Subordinate Courts, Bail before arrest and matters relating to transfer of cases will be fixed before the Honourable Chief Justice.
- 3) Urgent cases on the Original Civil Side will be fixed before the Senior Judge holding Court Sitting on Original Civil Side (OS-I). Cases which cannot be fixed before (OS-I) will be fixed before (OS-III) and vice versa and cases which cannot be fixed before (OS-I) and (OS-III) will be fixed before (OS-II). Cases which cannot be fixed before (OS-II) will be fixed before (OS-IV) and vice versa and cases which cannot be fixed before (OS-II) and (OS-IV) will be fixed before (OS-I). Similarly Cases which cannot be fixed before S.B-I (AS) will be fixed before S.B-IV (AS) and vice versa, and cases which cannot be fixed before S.B-I (AS) and S.B-IV (AS) will be fixed before SB-III (AS). Cases which cannot be fixed before SB-II (AS) will be fixed before SB-I (AS) and cases of SB-II which cannot be fixed before S.B-I (AS) will be fixed before SB-III (AS). Cases which cannot be fixed before SB-III (AS) will be fixed before SB-V (AS) and vice versa, and Cases which cannot be fixed before S.B-III (AS) and S.B-V (AS) will be fixed before SB-IV (AS).
- 4) Cases which cannot be fixed before the Hon'ble Judges sitting at appellate side will be fixed before senior most Judge of original side. Similarly cases which cannot be fixed before the Hon'ble Judges sitting at original side will be fixed before senior most Judge of appellate side.
- 5) Commercial Cases will be given priority over the other matters.
- 6) Cases of Special Appellate Court (Custom & Taxation) will be fixed before Hon'ble Mr. Justice Aftab Ahmed Gorar.
- 7) Any matter in which Learned Registrar or Learned MIT(s) of High Court of Sindh is a party, such cases will be fixed before the Divisional Bench to be headed by the Honourable Chief Justice, as well as any case / matter which Honourable Chief Justice desires to hear that will be fixed before the Honourable Chief Justice.
- 8) General Adjournments of Learned Advocates will not be allowed in Special Benches constituted on Original Sides.
- 9) Cases / matters on Appellate Side (SB) in which urgent permission is required to be sought other than Monday/s may be obtained / granted by Honourable Senior Judge sitting on Appellate Side (SB) as "J-1" except matters pertain to the jurisdiction of Honourable Chief Justice.

Cases which cannot be fixed before D.B-III will be fixed before DB-II and Case of D.B-III which cannot be fixed before D.B-II will be fixed before D.B-I. Cases which cannot be fixed before D.B-IV will be fixed before D.B-V and vice versa and cases which cannot be fixed before DB-IV & DB-V will be fixed before D.B-I.
- 2) Cases under various act; Contempt of Court cases received from the Subordinate Courts, Bail before arrest and matters relating to transfer of cases will be fixed before the Honourable Chief Justice.
- 3) Urgent cases on the Original Civil Side will be fixed before the Senior Judge holding Court Sitting on Original Civil Side (OS-I). Cases which cannot be fixed before (OS-I) will be fixed before (OS-IV) and vice versa and cases which cannot be fixed before (OS-I) and (OS-IV) will be fixed before (OS-III). Cases which cannot be fixed before (OS-II) will be fixed before (OS-I) and cases of (OS-II) which cannot be fixed before (OS-I) will be fixed before (OS-IV). Cases which cannot be fixed before (OS-III) will be fixed before (OS-V) and vice versa and cases which cannot be fixed before (OS-III) and (OS-V) will be fixed before (OS-I). Similarly Cases which cannot be fixed before S.B-I (AS) will be fixed as per direction of the Honourable Chief Justice. Cases which cannot be fixed before SB-II (AS) will be fixed before SB-VII (AS) and vice versa, and cases which cannot be fixed before S.B-II (AS) and S.B-VII (AS) will be fixed before SB-III (AS). Cases which cannot be fixed before S.B-III (AS) will be fixed before S.B-VI (AS) and vice versa, and cases which cannot be fixed before S.B-III (AS) and S.B-VI (AS) will be fixed before SB-V (AS). Cases which cannot be fixed before SB-IV (AS) will be fixed before SB-III (AS) and cases of SB-IV(AS) which cannot be fixed before S.B-III (AS) will be fixed before SB-IV (AS). Cases which cannot be fixed before SB-V (AS) will be fixed before SB-VIII (AS) and vice versa, and cases which cannot be fixed before S.B-V (AS) and S.B-VIII (AS) will be fixed before SB-III (AS).

- 4) Cases which cannot be fixed before the Hon'ble Judges sitting at appellate side will be fixed before senior most Judge of original side. Similarly cases which cannot be fixed before the Hon'ble Judges sitting at original side will be fixed before senior most Judge of appellate side.
- 5) Commercial Cases will be given priority over the other matters.
- 6) Cases of Special Appellate Court (Custom & Taxation) will be fixed before Hon'ble Mr. Justice Aftab Ahmed Gorar.
- 7) Any matter in which Learned Registrar or Learned MIT(s) of High Court of Sindh is a party, such cases will be fixed before the Divisional Bench to be headed by the Honourable Chief Justice, as well as any case / matter which Honourable Chief Justice desires to hear that will be fixed before the Honourable Chief Justice.
- 8) General Adjournments of Learned Advocates will not be allowed in Special Benches constituted on Original Sides.
- 9) Permission in those cases in which Division Benches are not available on Monday will be granted by the Hon'ble Chief Justice.
- 10) Cases / matters on Appellate Side (SB) in which urgent permission is required to be sought other than Monday/s may be obtained / granted by Honourable Senior Judge sitting on Appellate Side (SB) as "J-1" except matters pertain to the jurisdiction of Honourable Chief Justice.
